On 15 October 2008, the European Commission published a Green Paper on agricultural product quality and launched a large debate on the rules relating to the quality of the European agricultural production. The European legislation lays down high demands concerning the production of foodstuffs. It also includes a unique policy on geographical indications (Protected Denominations of Origin – PDO – and Protected Geographical Indications – PGI). A Chapter of the Green Paper deals with this policy and raises essential questions for the future of geographical indications in Europe.

The European Parliament (EP) is currently working on a response to the Green Paper. The committee for agriculture appointed Mrs Maria Petre (Romania – EPP – ED) to be rapporteur on this topic. The own-initiative report of the EP will bring an important contribution to the debate and outline some ideas of what could be the future European quality polity.

Mrs. **Maria Petre**, Member of the EP (Romania - EPP - ED), **OriGIn** (Organisation for an International Geographical Indications Network) and **CNAOC** (Confédération Nationale des Appellations d'Origine Contrôlée - France) organise on 3 December a round table on this subject. The event will bring together representatives of the geographical indications' sector, Members of the European Parliament, representatives of the European Commission, the French presidency, the future Czech Presidency and other member States. This round table aims at providing some food for thought and at identifying ideas regarding the future of the European quality policy.
