Under Article 5(2) of the Lisbon Agreement, the International Bureau notifies the competent authorities of all member countries in case of any new international registration of an appellation of origin. Refusals under Article 5(3) of the Agreement can be submitted by these competent authorities within one year from the date on which they receive the notification. This reception date is not necessarily the same for all competent authorities and is unlikely to be the same in cases in which the International Bureau has to send the notification by mail. For these reasons, the date on which the notification was dispatched is reflected until acknowledgment of receipt is received
